

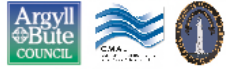

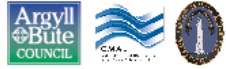

		<p>Invite A&BC council reps to meeting.</p> <p>Review of north entrance AtoNs.</p> <p>Clarification of projected harbour costs.</p>	<p>Cllr Robertson expressed her concern at a single corporate body taking control of the whole of Oban Bay. Her preference would be for a meaningful partnership in which all Stakeholders would have appropriate representation on the future management of the harbour.</p> <p>The evidence demonstrates that the common conjecture that the new seasonal buoyage is causing vessels to go aground at the Corran Ledge, is incorrect and that ignorance of buoyage and navigation is the root cause.
